1. Solid Waste-BUD

Mr. Krey reported that a request for proposals to solicit alternative daily cover has been prepared. Mr. Ernst said Chenango County awards two year contracts with options to renew for alternative daily cover. Currently Chenango County accepts the material for \$15.50 per ton, one company has \$18,000 on deposit with the County and the County draws down on the retainer when the firm brings in alternative daily cover materials. Mr. Krey said the RFP will be out this month, he said the County can accept up to 20% of its annual waste tonnage as beneficial use material. If the volume of waste at the landfill

increase the County can accept greater amounts of beneficial use material. There is a prohibition against stockpiling alternative cover, typically there are 2-10 piles of shale staged at the landfill which avoids the need to excavate shale daily. Mr. Ernst said even if the county receives ample supply of alternative cover he will still need to mine clay for extension of slopes as well as some shale for decking to get trucks in and out of the landfill cells.

Mr. Sudbrink asked Mr. Gale about the compaction rates of construction and demolition debris. Mr. Gale recommended the county look for material that does not include a high amount of puncture material.

Mr. Sudbrink said the county needs to revise solid waste operations, he asked Mr. Krey when the RFP would be issued. Mr. Krey said he expects the RFP to go out within two weeks.

2. Solid Waste-Purchase of Leachate Trailer

Mr. Ernst said Tritank has been doing quarterly inspections of the leachate tanker and they feel there is 1 to 2 years of useful life left. He said the tanker is a 2008 model and he recommends replacing it with an 8500 gallon 3 axle tanker. Mr. Ernst said the cost to replace the tanker will be around \$70,000. He believes the triple axle tanker would better displace the loads which would cause less damage to the roads in and around the landfill. In addition Mr. Ernst feels the larger tanker would allow for faster movement of leachate particularly during heavy rain events. Mr. Ernst would like to keep the current tanker as a back-up, he believes the tanker should be replaced sooner rather than later. The committee discussed constructing a pipeline to transport the leachate from the landfill to the sanitary sewers in Cortlandville. The committee talked about previous public opposition to this idea and the cost effectiveness of such a pipeline. Mr. Ernst said he would like to issue a request for proposal to solicit bids for a new tanker. There is currently \$600,000 in the equipment fund. Mr. Sudbrink called for a vote on the request, Discenza, Hartnett and Wheelock voted aye; Wagner and Sudbrink voted nay.

3. November 2017 Solid Waste Activities Report

Mr. Wagner asked if Flow Control is producing results, Mr. Ernst said he is seeing increased activity at the Landfill. Mr. Hartnett asked why the landfill is only open one Saturday a month, he suggested that the schedule should be revisited to reflect the increased tonnage that will come with flow control. Mr. Sudbrink said he would like to see fliers at the landfill reminding haulers what the penalties are if they are caught taking waste out of the County. He urged Mr. Ernst to increase awareness of the flow control law, as he is concerned that smaller haulers may not be aware of the fines.

Early assessment of Flow Control participation;

Operations

Leachate Hauling – Continued transport of leachate to the City’s WWTP, current reading at 8.6' total tank.

Site Maintenance – Early season snow removal, continued placement of bagged trash into second half of Cell 2A, stockpile shale for winter use.

Equipment – Repairs to dozer (Unit 205) and haul truck (Unit 209); routine service of equipment and vehicles.

Recycling

- E-waste Recycling from October 2017 was approximately 12.48 tons at a cost to the County of \$4,046.12. The NYSDEC grant program to reimburse 50% of e-waste recycling has been extended from April 1st through the end of 2017. Applications are due in January 2018. Total reimbursement through the end of 2017 to be requested from NYSDEC is estimated to be \$22,000.
- Single-stream recycling for January through October 2017 received approximately 2,463 tons of materials at a cost of \$157,133.07. This total reflects the value of the commodities of \$25,360.63 paid to the County.
- Environmental Improvement Committee did not meet in November 2017. The committee has tentatively scheduled its next meeting for December 19, 2017.
