Inter-Mutual Agreement Between Cortland County and Schuyler County -Sheriff's Department

RESOLVED, that the Chairman of the Legislature, and the Sheriff of Cortland County upon review and approval by the County Attorney or designee, be and hereby is authorized to sign an agreement for Mutual Aid (Police Services) for Schuyler County.
