Authorize Applications for New York State Department of Transportation Grant to Fund New Airport Box Hangar and New Ceilometer and Camera System - Cortland County Airport / Highway Department

WHEREAS, the County of Cortland owns the Cortland County Airport, General Levi R. Chase Field, and as owner, is eligible for New York State Department of Transportation (NYSDOT) grant monies for Airport improvement projects, AND

WHEREAS, the NYSDOT is soliciting grant applications from airports in New York State for capital projects under its 2017 Aviation Capital Grant Program, AND

WHEREAS, the County of Cortland desires to continue to provide improved services, safety, and revenue generation at the airport, AND

WHEREAS, the grant funding for awarded projects will be available at participation levels of up to \$1,666,666, 90% of which will be provided by State funding, AND

WHEREAS, Cortland County would be responsible for the 10% local share of the maximum grant awarded at \$166,666, NOW, THEREFORE BE IT

RESOLVED, that the County of Cortland hereby approves the submission of an application for a new box hangar, and an application for a new ceilometer and camera system to be constructed at the Cortland County Airport.
